ADDA Policies and ADDA Forms | Human Resources

Specifically, under the Arizona Employment Protection Act, it is the public policy of the state that the employment relationship may be terminated at the will of either the employee or the employer unless the parties have signed a written contract to the contrary. Both the employer and the employee must sign such a written contract or it must be set forth in an employment handbook, manual, or similar document that is distributed to the employee.

State of Arizona employees who are covered are granted certain rights and responsibilities. However, no employee acquires employee rights in excess of, or in addition to those authorized under the State Personnel Rules or Arizona Revised Statutes.

State Personnel Rules | Human Resources

Employee negligence, normal wear, failure to comply with employer reporting requirements and caps are included exceptions. The law provides employees with thirty days in which to report expenses. Another law ensures that nursing employees have reasonable paid break time in which to express milk.

These guidelines include the circumstances under which testing can be administered, actual administration of the test, notice to the employee and the employee's rights. Equal Pay for Men and Women Federal and Arizona laws prohibit employers from paying an employee less than the rate paid to employees of the opposite sex for the same quantity and quality of the same classification of work.

Under Arizona law, employees are generally considered at-will. See At-Will Employment Status. In certain circumstances, the employee handbook may modify the at-will employment relationship. See Employment Contracts and Modifying the At-Will Employment Relationship. An employee handbook may constitute an employment contract under certain circumstances.

State Personnel System Employee Handbook State Executive Branch Arizona's executive branch is headed by a governor, who is elected to a four-year term. The governor may serve any number of terms, though no more than two in a row. Other elected executive officials include the Secretary of State, State Treasurer, State Attorney General.

Arizona - Leave Laws - Employment Law Handbook

Arizona does not have any labor laws requiring an employer to provide a meal period or breaks to employees, thus the federal rule applies. The federal rule does not require an employer to provide either a meal (lunch) period or breaks. However, if an employer chooses to do so, breaks, usually of the type lasting less than 20 minutes, must be paid.

A state employee may seek employment and engage in a variety of activities outside of the employee's work for the state; however, the employee shall not engage in other employment or other activity that is not compatible with the full and proper discharge of the duties and responsibilities of state employment, or that tends to impair the employee's capacity to perform the employee's duties and responsibilities in an acceptable manner.

Because the handbook is now a legal contract, Arizona law requires that any modification of its terms must be made by mutual consent of the parties and for consideration. Consideration requires the employer to give the employee something of value, like money.

In Arizona, a private employer can require an employee to work holidays. A private employer does not have to pay an employee premium pay, such as 1½ times the regular rate, for working on holidays, unless such time worked qualifies the employee for overtime under standard overtime laws.
