Juror information can only be released by court order. Be Alert To Scams: Commissioners' offices never ask for financial or family information, including your SSN, over the phone. Do not give this kind of information to anyone claiming to represent the court regarding jury duty via phone or email.

Jury And The Search For

A jury is a sworn body of people (the jurors) convened to render an impartial verdict (a finding of fact on a question) officially submitted to them by a court, or to set a penalty or judgment. Their function was therefore closer to that of a grand jury than that of a jury in a trial.

Grand juries in the United States are groups of citizens empowered by United States federal or state law to conduct legal proceedings, chiefly investigating potential criminal conduct and determining whether criminal charges should be brought. The grand jury originated under the law of England and spread through colonization to other jurisdictions as part of the common law. Today, however, the United States is one of only two jurisdictions, along with Liberia, that continues to use the grand jur
